BEML has exported 1300+ units of Mining & Construction equipment and spare parts worth about US\$ 300 million to 70+ countries of various continents.

BEML operates in following three business verticals;

1. **Mining & Construction:** Manufacturing of Bull Dozers, Wheeled Dozers, Back Hoe Loaders, Motor Graders, Pipe Layers, Dumpers, Water Sprinklers, Excavators, Tyre Handlers and other various equipment including spare parts.

BEML is exporting various equipment and spare parts to different countries and intends for empanelment of C&F agencies for a period of 2 years, for Clearance / Freight and Clearance activities like shipment of equipment & spare parts from different Indian air/sea/land ports, ICD/ CWC to various countries across the globe, for the activities like customs clearance at CFS/Indian air/sea/land port and ICD/CWC, sea/land/air transportation from any Indian Port to various countries through all types Container/ RO-RO/ Break-bulk vessels, Air, Land transportation and Inland transportation including Import clearance in respective countries (as the case may be).

Empanelment does not guarantee allocation of any volume of business.

Once C&F agencies are empaneled, BEML will contact the empaneled C&F agencies to avail the aforesaid services or part of services, by calling separate tender through SRM portal / email / Gem portal or as per BEML procurement policy applicable at that time, on case-to-case basis, as and when required.

4. ELIGIBILITY CRITERIA:

- a. The bidder's company should be registered in India and preferably should have an office in Bangalore and details should be provided in **Annexure-A**.
- b. The bidder's company should have PAN card and GST registration certificate and details should be provided in **ANNEXURE-A**.
- c. The bidder or its authorized associate (supported by valid authorization letter) should possess a valid CHA License and details should be provided in **ANNEXURE-A**.
- d. The bidder should have minimum 3 years' experience in C&F / logistics operations and details should be provided in **ANNEXURE-A**.

5. **INSTRUCTIONS TO BIDDERS:**

Bidders are required to be submitted the following document/ details along with supporting documents through **e-mail to bemleoi@bemltd.in** ;

- a. Duly filled, signed and stamped **Technical Response (Annexure-A)** along with all the supporting documents to be mailed to bemleoi@bemltd.in .

Responses against EOI shall not be considered for evaluation for the following deviations;

3. Kindly note that bidders having sister concerns are requested to submit response to EOI from any one firm only. If response(s) are received from both parent and sister companies against the EOI, BEML reserves the right to reject both responses received from the parent and sister companies.
4. The bidder is advised to go through all the terms and conditions of EOI carefully before submitting.
5. In case any person/persons, Company, firm, Associations having any litigations, arbitration cases between themselves and BEML Ltd, pending before the Court / Arbitrator or initiated litigations/arbitrations in connection with any contract / tender issued by BEML Ltd and any contractor has defaulted against the BEML's orders are not eligible to participate in this Eoi.
6. If a bidder has executed any of the purchase orders / contracts in the past amounting to undue / abnormal delay in execution, their EOI's will not be considered for evaluation and same will be rejected.
7. Feedback from user department of BEML will be considered for evaluation of EOI's and is a mandatory criteria.

8. All entries in the response & related document shall be in English either typed or written legibly in black or blue ink only. Over-writings are not permitted. All cancellations and insertions shall be duly signed / attested by the authorized person.
9. Bidders are requested to indicate their contact person details with valid E-mail ID, Telephone number/Mobile Number and correspondence address clearly in their responses. Any communication / correspondence from BEML will be communicated through E-mails/contact number/correspondence address which is provided by the bidder in their response.
10. Non-compliance with any of the EOI conditions set forth thereon and incomplete, conditional and ambiguous responses are liable for rejection.
11. The bidder shall fill in all the required particulars in the blank space provided for the purpose in the EOI document and shall also affix stamp and sign on each and every page of EOI document before submitting the response through email, as a token of acceptance of the EOI terms & conditions. Any corrections/ revisions will not be allowed after closing date and time of EOI.
12. BEML reserves its right to reject a response due to unsatisfactory past performance in the execution of a contract at any of BEML projects / units.
13. The due date for submission of responses may be extended by BEML, **in its sole discretion**, which shall be announced as **corrigendum to original EOI only at BEML Limited's website**. Validity of responses submitted shall be deemed to be extended accordingly.
14. BEML may decide to scrap the EOI / re-float the EOI without assigning any reasons thereof before finalization of empanelment. BEML reserves the right to accept, cancel or reject any response or reject all responses at any time prior to the empanelment without incurring any liability to the affected bidders or any obligation to inform affected bidder, the grounds of such action.
15. Bidders participating in the EOI should declare in their response that whether they have been black-listed / kept on hold for a specified period / given Business holiday for a specified period by any Public sector undertaking or Government departments. The reasons for such action with details and the current status of such hold shall be furnished to BEML. If no such details are mentioned in the response then it will be construed that the subject bidder is not under any such hold. But at a later date if it comes to the notice of BEML about any such hold under enforcement on the subject bidder, BEML will have every right to reject the response of such bidders at any point of time and also under any stage of the finalization of the empanelment irrespective of the status of the subject bidder in the EOI. In case, if bidder(s) is empanelled by BEML, but at a later date if it comes to the notice of BEML about any such hold under enforcement on the subject bidder, BEML reserves the right to cancel the empanelment without assigning any reasons thereof. Suitable action against such bidders will be initiated for blacklisting/ keeping on hold for specific period and will be communicated suitably. Also, they will not be considered for any ongoing tenders/ EOI even if participated till the hold is officially lifted and confirmed in writing. BEML's decision in this regard shall be final and binding.

9. SCOPE OF WORK:

1. Broad scope of work for **20 feet/ 40 feet – Flat Rack/ High Cube/Open Top/ Closed Container shipment** includes the following:
 - a. C&F activities at the CFS of any port of loading in India.
 - b. Assembly of equipment, if required.
 - c. Placement of suitable containers at CFS, if required. Stuffing, lashing and custom clearance at CFS. Movement of loaded container(s) from CFS to port of loading for onward shipment to discharge port of designated country by sea.
 - d. Arranging suitable vessel and ocean freight for the entire fleet of equipment/ spare parts from loading port to discharge port, if required.

- e. Arranging for C&F activities at destination port, if required.
- f. Loading the cargo onto the suitable trailers and arranging Inland transport from discharge port to final delivery place at designated country, if required.
- g. Unloading and handing over the goods to at final delivery place, if required.

Note: Above mentioned Scope of work is indicative, however actual scope of work will be indicated in tender on case-to-case basis.

2. Broad scope of work for RO-RO/ Break-Bulk shipment includes the following:

- a. C&F activities at the port of loading in India.
- b. Assembly of BEML equipment at loading port, if required.
- c. Loading of static cargo/ spare part/ tool boxes on the MAFI's, if required. Lashing and dunnage material has to be arranged by the successful bidder and MAFI's to be loaded inside the vessel.
- d. Arranging suitable vessel and ocean freight for the fleet of equipment/ goods from loading port to destination port, if required.
- e. Unloading cargo at discharge port arranging for port clearances, if required.
- f. Loading the cargo onto the suitable trailers and arranging Inland transport from discharge port to final delivery place at designated country, if required.
- g. Unloading and handing over the goods to at final delivery place, if required.

Note: Above mentioned Scope of work is indicative, however actual scope of work will be indicated in tender on case-to-case basis.

3. Broad scope of work for shipment of goods through land port of India & neighbouring countries border includes the following:

- a. Transportation of goods (equipment/ spare parts/ tool boxes) in fully/ partially assembled condition from BEML, Mysore/ KGF/Bangalore, Karnataka/ BEML, Palakkad, Kerala to land-border/ port in standard/ semi-low bed/ low bed trailer(s), if required.
- b. Receiving the cargo at land port of India.
- c. C&F activities at land port of India.
- d. C&F activities neighbouring country boarder, if required.
- e. To provide storage facility with safety and security of Cargo at boarder ports, if required.
- f. Transporting cargo from neighbouring country border port to delivery place in standard/ semi-low bed/ low bed trailer(s), if required.
- g. Unloading and handing over the goods to at final delivery place, if required.

Note: Above mentioned Scope of work is indicative, however actual scope of work will be indicated in tender on case-to-case basis.

4. Broad scope of work for LCL/FCL in Closed Container shipment from any ICD/CWC at India includes the following:

- a. C & F activities at any ICD/ CWC in India, if required.
- b. Placement of suitable containers at any ICD/ CWC in India, if required.
- c. Arranging ocean freight from designated Indian sea port to Destination country port, if required.
- d. Arranging for C&F activities at destination port, if required.
- e. Loading the cargo onto the suitable trailers and arranging Inland transport from discharge port to final delivery place at designated country, if required.
- f. Unloading and handing over the goods at final delivery place, if required.

Note: Above mentioned Scope of work is indicative, however actual scope of work will be indicated in tender on case-to-case basis.

5. Broad scope of work for Air Shipment from any Indian Air Port includes the following:

- a. C & F activities at any Airport in India, if required.

- b. Arrangement Air freight from designated Indian airport to Destination country airport, if required.
- c. Arranging for C&F activities at destination airport, if required.
- d. Transporting cargo from destination airport to delivery place, if required.
- e. Unloading and handing over the goods at final delivery place, if required.

Note: Above mentioned Scope of work is indicative, however actual scope of work will be indicated in tender on case-to-case basis.

10. SPECIAL TERMS AND CONDITIONS:

1. EMPANELMENT PERIOD:

- 1. The Empanelment is valid for a period of 2 years from the date of issuance of Empanelment letter.
- 2. Empanelled members have to assure BEML for validity of all the required documents / technical documents till the validity of this contract.

2. CARGO AND SHIPMENT DETAILS:

Cargo dimensions & weight and shipment details shall be shared on case-to-case basis in specific tender, which will be floated to empanelled bidders and L1 bidder will be awarded for contract from empanelled bidders on case-to-case basis tenders

3. Ernest Money Deposit (EMD) & Performance Bank Guarantee (PBG):

EMD & PBG amount will be decided on case-to-case basis for specific tender, which will be floated to empanelled bidders.

4. RIGHT OF BEML:

BEML reserves right for the following:

- a) To accept or reject all or any of the response, without assigning any reason.
- b) In case BEML is not satisfied with the quality of work of the empanelled bidder(s), BEML reserves the right to terminate the empanelment.

5. CONFIDENTIALITY:

Empanelled Bidder shall not divulge any information with regard to goods and documents etc. to any person or agency without written permission from BEML. In event of violation, the empanelment will automatically stand cancelled.

6. INDEPENDENT AGENCY:

The Empanelled Bidder shall always be regarded as an independent agency and their employees shall not at any time be regarded as the employee of the BEML. BEML shall not be liable/ responsible for damage, loss or injury if any caused to life or property of any persons, or employees of the Empanelled Bidder by reason of any acts of Omission or negligence on their part.

Nor shall the BEML be liable / responsible for claims, if any, of the employees of the Empanelled Bidder under the Workmen's Compensation Act or any other enactment. The Empanelled Bidder shall always keep BEML fully indemnified against all such claims and proceedings, if any, of their employees or their agents against the BEML.

7. ASSIGNMENT OR SUB-LETTING OF CONTRACT:

Empanelled Bidder shall not, at any time during the contractual period, assign or sub-let the contract in full or any part thereof to any person without the prior permission in writing from BEML. Any contravention of this condition shall entitle BEML to terminate the empanelment.
