Commodity EXIM Report DGCI & S, I T J Division

- 1. The weekly EXIM Report published by ITJ Division of DGCI&S, Kolkata presents some basic insights into India's export and import trade patterns with respect to selected set of commodities identified each week in order to facilitate preliminary commodity group/sector specific analysis for informed trade decision making.
- 2. For both categories of trades, one commodity group is chosen from the entire ITC-HS 4-digit Classification (latest being 2024 classification system). The Indian Trade Classification based on Harmonized System has been adopted in India for Export and Import Operations. While India specific data is sourced from DGCI&S, M/o C&I Database, global export-import data of exactly those sets of commodities are sourced from UN-COMTRADE Database.
- 3. As regards the time-period, this report outlines trade statistics over a period of four years, i.e., 2021 to 2024. The latest finalized data available on the UN Comtrade Database is only up to year 2024 (Calendar Year) and on the DGCI&S Database up to August, 2025. So, for each commodity group dealt in this report, trends from 2021 to 2024 have been showcased where data has been sourced from UN Comtrade and from DGCI&S database.
- 4. In the instant report [4th weekly Commodity Exim Report of October, 2025 dated 22nd October, 2025] the following two commodities have been dealt with.

Export: Heterocyclic Compounds with Nitrogen Hetero-Atom(s) only [ITCHS Code – 2933] - In the year 2024 this commodity group had 1.21% share in India's total Export value basket as per DGCI&S database. India occupied the 4th slot in export of this commodity (5306.80 million USD) with 5.87% share of total global exports in the year 2024.

Import: Parts and Accessories of the Motor Vehicles [ITCHS Code –8708] – In the year 2024 this commodity group had share of 0.86% in India's total Import value basket as per DGCI&S database. India having 1.42% share of total global imports of this commodity occupied the 19th slot in the year 2024.

EXPORT

Heterocyclic Compounds with Nitrogen Hetero-Atom(s) classified as ITCHS Code – 2933 falls under Chapter – 29 (Organic chemicals) of Section- VI (Products of the Chemical or Allied Industries) of ITC-HS classification.

India is engaged in the process of exporting this commodity and in 2024 this commodity group had 1.21% share in India's total Export value basket as per DGCI&S database.

India's Top 10 destination for Heterocyclic Compounds with Nitrogen Hetero-Atom(s) (HS Code – 2933)



India's top 10 destinations of Heterocyclic Compounds with Nitrogen Hetero-Atom(s) by Percentage in 2024




The total value of exports of Heterocyclic Compounds with Nitrogen Hetero-Atoms(s) only from India amounted to USD 5369.54 million in 2024 with a huge increase by 34.86% compared to 2023 figures of USD 3981.50 million. For, the period under review, India's exports in this segment increased in 2022 compared to 2021, then a little dip in 2023 over 2022 and a huge leap in 2024. Singapore (USD 1604.99 million) held the top slot as an export destination in this segment from India with 29.89% share of India's total exports of this product group in 2024. In second and third place were USA (USD 328.30 million) and Switzerland (USD 264.58 million) to where India exported around 6.11% and 4.93% share of Heterocyclic Compounds with Nitrogen Hetero-Atom(s) respectively in 2024.



World's 10 leading exporters of Heterocyclic Compounds with Nitrogen Hetero-Atoms(s) by percentage in 2024




The worldwide export of Heterocyclic Compounds with Nitrogen Hetero-Atom(s) only amounted to USD 90457.16 million in 2024, decreased by 17.85% over the previous year. The lead Exporter in this segment was Switzerland (exporting goods worth a total of USD 33721.73 million) with 37.28% share in 2024 followed by Ireland (USD 16655.98 million) and China (USD 11317.79 million) with 18.41% and 12.51% shares of world exports in this segment in 2024 respectively. **India** (exporting goods worth a total of USD 5306.80 million) with 5.87% share, stood at 4th slot in 2024 of world export of Heterocyclic Compounds with Nitrogen Hetero-Atom(s) only.




World's 10 leading importers of Heterocyclic Compounds with Nitrogen Hetero-Atom(s) only (by percentage share in 2024)



The worldwide imports of Heterocyclic Compounds with Nitrogen Hetero-Atom(s) was USD 93398.42 million in 2024, decreased by 25.25% from 2023 levels. Over the period under review global imports were at record high in 2022. The lead importer in this segment with highest share of imports were Slovenia (21.60% share in 2024) followed next by USA (13.32%) and Germany (12.87%). **India** had 2.44% share in world importing trade in this segment and occupied the 11th slot in 2024. Over the period under review Germany was the largest importer in global import of Heterocyclic Compounds with Nitrogen Hetero-Atom(s) only till 2023.


As per **UN Comtrade database** the top 3 importers of Heterocyclic Compounds with Nitrogen were **Slovenia, USA and Germany**. These three countries imported 30.53%, 5.53% and 2.39% share of their total import of this commodity from India in 2024 which are presented below:



IMPORT

Parts and Accessories of the Motor Vehicles classified as H.S. Code – 8708 falls under Chapter -87 (Vehicles other than railway or tramway rolling-stock, and parts and accessories thereof) of Section-XVII (Vehicles, Aircraft, Vessels and Associated Transport Equipment) of ITC-HS classification.

India is engaged in the process of importing this commodity and in 2024 this commodity group had 0.86% share in India's total Import value basket as per DGCI&S database.

The total amount of India's imports of Parts and Accessories of the Motor Vehicles in 2024 stood at USD 6174.84 million, increased approximately by 4.51% over 2023 level. Over the period under review, India's imports in this segment were at record high in 2024. In 2023-24, China stood out as India's top importing partner in this segment with a share of 22.59% followed next by Japan (15.22%) and Germany (13.55%). India's import in this segment had upward trend till 2024.

Total global imports of **Parts and Accessories of the Motor Vehicles** worldwide was USD 428510.45 million in 2024, decreased by 4.39% from 2023 levels. Over the period under review, global imports were at record high in 2023 and from 2020 to 2023 the there was a upward trend till 2023 and then a moderate dip in 2024.

India's imports amounted to approximately USD 6076.17 million in the year 2024 as per UN Comtrade database and **India** ranked 19th in the world with the share of 1.42% of total global imports of this commodity. The lead importers in this segment were USA (USD 89905.78 million), Germany (USD 47459.55 million) and Mexico (USD 34363.75 million) with 20.98%, 11.08% and 8.02% share of global imports of this commodity respectively in 2024.
