Commodity EXIM Report DGCI & S, I T J Division

- 1. The weekly EXIM Report published by ITJ Division of DGCI&S, Kolkata presents some basic insights into India's export and import trade patterns with respect to selected set of commodities identified each week in order to facilitate preliminary commodity group/sector specific analysis for informed trade decision making.
- 2. For both categories of trades, one commodity group is chosen from the entire ITC-HS 4-digit Classification (latest being 2024 classification system). The Indian Trade Classification based on Harmonized System has been adopted in India for Export and Import Operations. While India specific data is sourced from DGCI&S, M/o C&I Database, global export-import data of exactly those sets of commodities are sourced from UN-COMTRADE Database.
- 3. As regards the time-period, this report outlines trade statistics over a period of four years, i.e., 2021 to 2024. The latest finalized data available on the UN Comtrade Database is only up to year 2024 (Calendar Year) and on DGCI&S Database up to September, 2025. So, for each commodity group dealt in this report, trends from 2021 to 2024 have been showcased where data has been sourced from UN Comtrade and from DGCI&S database.
- 4. In the instant report [3rd weekly Commodity Exim Report of November ,2025 dated 19th November, 2025] the following two commodities have been dealt with.

Export: Cotton Yarn (other than Sewing Thread), Containing 85% or more by Weight of Cotton. [ITCHS Code –5205] -In 2024 this commodity group had 0.76% share in India's total Export value basket as per DGCI&S database. As per UN Comtrade database India occupied the top slot in export of this commodity (3305.31 million USD) with 33.98% share of total global exports in the year 2024.

Import: Ferrous waste and Scrap; Remelting Scrap Ingots of Iron or Steel [ITCHS Code – 7204] – In 2024 this commodity group had share of 0.71% in India's total Import value basket as per DGCI&S database. India having 12.93% share of total global imports of this commodity (5049.44 million USD) occupied the 2nd slot in the world in 2024.

EXPORT

Cotton Yarn (other than Sewing Thread), Containing 85% or more by Weight of Cotton classified as H.S. Code – 5205 falls under Chapter -52 (Cotton) of Section XI (Textiles and Textile Articles) of ITC-HS classification. India is engaged in the process of exporting this commodity and in 2024 this commodity group had 0.76% share in India's total Export value basket as per DGCI&S database.



India's top 10 destinations of Cotton Yarn (other than Sewing Thread), Containing 85% or more by weight of Cotton (percentage share in 2024)



The total value of exports of Cotton Yarn (other than Sewing Thread), Containing 85% or more by weight of Cotton from India amounted to USD 3357.81 million in 2024, decreased by 4.05% from 2023 levels.


Bangladesh (importing goods worth USD 1573.54 million in this segment from India) held the top position as an export destination in this segment from India with 46.86% share of India's total exports of Cotton Yarn (other than Sewing Thread), Containing 85% or more by weight of Cotton in 2024. In second and third place in the year 2024 were China (USD 291.47 million) and Vietnam (USD 167.48 million) to where India exported around 8.68% and 4.99% share of total Cotton Yarn (other than Sewing Thread), Containing 85% or more by weight of Cotton respectively. Exports from India in this segment (as measured in value terms) decreased in 2022 over the year 2021 and followed by a leap in 2023 and again a little dip in 2024.



World's 10 leading exporters of Cotton Yarn (other than Sewing Thread), Containing 85% or more by weight of Cotton (percentage share in 2024):




The global export of Cotton Yarn (other than Sewing Thread), Containing 85% or more by weight of Cotton reached USD 9725.79 million in 2024, decreasing by more than 17.64% vis-à-vis the previous year's figure. The lead exporter in this segment has consistently been **India** (exporting goods worth a total of USD 3305.31 million) with 33.98% share in 2024 followed by Uzbekistan (USD 1967.17 million) and China (USD 842.72 million) with 20.23% and 8.66% respectively.




World's 10 leading importers of Cotton Yarn (other than Sewing Thread), Containing 85% or more by weight of Cotton percentage share in 2024




In 2024, the total global imports of goods in this segment amounted to USD 7328.13 million, decreased by 14.77% vis-à-vis the previous year's figure. In 2024, **India** occupied the 34th position by way of importing up to 0.32 % of global imports in this segment. Top 3 major importing countries were China, Turkiye and Portugal with 44.52%, 6.47% and 4.59% shares respectively. Total Import value in this segment continuously decreased till 2024.

As per UN Comtrade database the top 3 importers of Cotton Yarn (other than Sewing Thread), Containing 85% or more by weight of Cotton were **China**, **Turkiye and Portugal**. These three country China, Turkiye and Portugal imported 9.38%, 13.05% and 37.46% share of their total import of this commodity from India in 2024 which are presented below:



IMPORT

Ferrous waste and Scrap; Remelting Scrap Ingots of Iron or Steel as ITCHS Code – **7204** falls under Chapter -72 (Iron and steel) of Section – XV (Base Metals and Articles of Base Metal) of ITC-HS Classification.

India is engaged in the process of importing this commodity and in the 2024 this commodity group had share of 0.71% in India's total Import value basket as per DGCI&S database.

In 2024 India imported a total of USD 5126.58 million worth of Ferrous waste and Scrap; Remelting Scrap Ingots of Iron or Steel, a huge decline by 24.45% compared to the year 2023. As per available data, USA stood out as India's top importing partner in this segment with a share of 15.02% of India's total import value in this segment in 2024. Next in line comes UK and UAE with shares of 9.32% and 6.53% respectively. India's import value in this segment steadily increased till 2023 and then a huge dip in 2024 from 2023.

Worldwide import of Ferrous waste and Scrap; Remelting Scrap Ingots of Iron or Steel totalled to USD 39054.41 million in 2024, declined by nearly 10.43% over 2023 levels. Turkiye imported USD 8327.07 million worth of the commodity in 2024, making it the leading importer of the commodity group worldwide with 21.32% share of world imports. The import value of Ferrous waste and Scrap; Remelting Scrap Ingots of Iron or Steel in **India** amounted to approximately USD 5049.44 million in the year 2024 and ranked 2nd slot in the world with the share of 12.93% of total global import value of goods in this segment, followed by Belgium with a share of 6.90%. Over the period under review the trends of Global import of Ferrous waste and Scrap; Remelting Scrap Ingots of Iron or Steel was downward till 2024.
