The tenderers may submit tenders for the work given in the Table in Two Tender Document System i.e., 1<sup>st</sup> Electronic tender document, i.e., Technical Bid & 2<sup>nd</sup> Electronic tender document i.e Financial bid, procedure as per Rule28 of the KTPP Act shall be followed. The Tenders are required to submit two separate electronic document 1st Electronic tender document containing the Earnest money deposit and the details of their capability to undertake the tender (as detailed in ITT Clause 3 and 6), which will be opened first and the Second Electronic tender document containing the price tender (Financial Bid) which will be opened only if the Tenderer is found to be qualified to execute the tendered works. The Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderers to qualify for award of the contract.

- 1. The amount put to tender is excluding 18% GST of Rs. 26288.48 Lakhs. The bidder should quote for the amount put to tender. However GST will be paid separately as per the prevailing rates as applicable under laws subject to the conditions mentioned in the Govt. circular No. FD 417 EXP-12/2024 dated 09-08-2024.
- 2. Estimate rates are excluding GST as per current Common SR and prevailing GST (18% of Amount Put to tender) amount is kept in form of Lump sum in sanctioned estimate according to guidelines in Common SR (GO:PWD 51 RDF 2019 Bangaluru Dt:18.03.2022). Therefore, amount put to Tender and ECV amount are excluding GST. ### 3. INSTRUCTIONS TO TENDERERS

#### PRE-QUALIFICATION STIPULATIONS

- First Electronic tender document(on line Technical bid) shall contain the following documents. 3.1
  - 1. A copy of the valid Karnataka PWD Class-I/CPWD Class-I(Super) & above civil contractor registration certificate.
  - 2. A copy of the valid Employees Provident Fund (EPF) registration Certificate.
  - Each tenderer must pay specified full E.M.D. in the KPPP platform through any of the payment modes as:- a) Credit card b) Direct Debit e)National Electronic fund transfer (NEFT) d)Over the counter (OTC). Tenders without valid E.M.D. shall be rejected.
  - 4. The valid copy of GST Registration Certificate
  - 5. The annual turnover of intending bidder shall not be less than the two times the amount put to tender i.e., Rs.31020.41 Lakhs. (Rs. 31020.41 Lakhs x 2 x 12 months / 24 months) usually not less than 2 times the estimated annual payments under this contract) Calculated as per Govt. circular PWD 60 CRM 2021 Dated 08/11/2021)in any two financial years during the last 5 years i.e, from 2019-20 to 2023-24 (in all Classes of Civil Engineering Construction works only). The audit Profit and Loss account certified by a practicing Chartered Accountant duly showing with UDIN i.e (Unique Document Identification Number) along with income tax return filed should be uploaded. The intending bidder should have in last five years i.e., from 2019-20 to 2023-24 satisfactorily completed (at least 90% of the contract value) as a prime contractor at least one similar nature of work such as Open Canal distribution Network/ Lift irrigation Scheme with canal distribution network including lining and CD works such as Troughs, Aqueducts etc., of value not less than 50% of the estimate value of amount put to tender i.e., Rs.15510.21 Lakhs. The Work done certificates obtained from the officer not below rank of Executive Engineer should be uploaded. The work done value of the previous year shall be updated to present price level of 2024-25 at 10% per annum.

- 8. Each Tenderer should further demonstrate:
  - (a) Availability by owning the following key and critical equipment for this work:

    The intending bidder / firm / company should furnish details of ownership of Machineries/Equipments etc., to an extent of more than 50% of the requirement and also should furnish copies of lease agreement of hiring of Machineries/Equipments etc., to be deployed for this work.

- 9. Liquid assets and or availability of credit facilities of not less than Rs. 3877.55 lakhs (3/24x31020.41) (Credit Lines/Letters of Credit/Certificates from Nationalized Banks) for meeting the fund requirement etc., The Contractor should upload necessary documents issued by the Nationalized banks as per prescribed formats enclosed as ANNEXURE I.
- 10. GST declaration certificate is mandatory and shall be uploaded in the suggested format enclosed as ANNEXURE II
- 11. Tenderers who meet the above specified minimum qualifying criteria, will only be qualified, if their available tender capacity is more than the total tender value. The available tender capacity will be calculated as under:

## Assessed available tender capacity = (A\*N\*1.5 - B)

- A = Maximum value of civil engineering works executed in any one year during the last five years (updated to 2024-25 price level) taking into account the completed as well as works in progress.
- N = Number of years prescribed for completion of the works for which tenders are invited.
- B = Value, at 2024-25 price level, of existing commitments and on-going works to be completed during the next 24/12 year (period of completion of the works for which Tender are invited) form the probable date of Award of this contract.

**Note:** a) The statements showing the value of existing commitments and on-going works as well as the stipulated period of completion remaining for each of the works listed should be countersigned by the Employer in charge, not below the rank of an Executive Engineer or equivalent

3.2 Second Electronic tender document-Financial bid.

The Second Electronic document i.e., Financial bid of all the participated bidder will be opened after approval of the technical bid qualification among eligible bidders the lowest bidder will be identified. If the lowest bidder fails to produce the original documents for entering into an agreement or the original documents submitted does not match with the uploaded documents or found false, then his bid is treated as non-responsive bid as per clause-26(4) of the KTPP rules & his name would be recommended for the removal from the select list of KPWD enrolment and barred from participation in any of the tenders invited by the KNNL apart from forfeiting the EMD paid through e-cash.

#### **General Conditions**

1. All the documents must be attested, scanned and uploaded.

- 2. The contractor should neither make any alteration in the conditions of contract or not stipulate any conditions of his own.
- 3. The 2nd Electronic document i.e., Financial bid of all the participated bidder will be opened after approval of the technical bid qualification among eligible bidders the lowest bidder will be identified. If the lowest bidder fails to produce the original documents for entering into an agreement or the original documents submitted does not match with the uploaded documents or found false, then his bid is treated as non-responsive bid as per clause-26(4) of the KTPP rules & his name would be recommended for the removal from the select list of KPWD enrolment and barred from participation in any of the tenders invited by the KNNL apart from forfeiting the EMD paid through e-cash.
- 4. Evaluation will be done based on the information provided by the contractor as per the document uploaded through e-procurement the correctness of the uploaded document will be verified if necessary.
- 5. Any bidders who is otherwise technically qualified withdraws from the bidding process at any stage before a final decisions taken on the tender, the EMD of such bidder shall be forfeited, the name of such bidder shall be recommended for removal from the KPWD contractors at least for a minimum period of one year in KNNL, besides making such bidders liable for black listing.
- 6. Any of the bidder who withdraws from the bidding process after completion of tender submission date at any stage before a final decision taken on the tender, the EMD of such bidder shall be forfeited and the name of such bidder shall be removed from the select list of KPWD registration and barred from participation in any of the tenders invited by KNNL thereafter
- 7. GST: The tenderer should quote the rate with respect to the amount shown as work portion Part-A in Column No-3 of Statement showing the details of work under Invitation For Tenders (IFT). However GST will be paid separately as per the prevailing rates as applicable under laws subject to the conditions mentioned in the Govt. circular No. FD 417 EXP-12/2024 dated 09-08-2024.
- 8. The bidders shall ensure credit of Tender Processing Fee and EMD into the respective receiving bank accounts of e-procurement on or before the last date of bid submission (Through Electronic Media)
- 9. The tenderer is required to ensure browser compatibility of the computer well in advance to the last date and time for receipt of tenders. The department shall not be responsible for non-accessibility of e-Procurement portal due to internet connectivity issues and technical glitches.
- 10. Even though the agency/firm meets the qualifying criteria, they are subjected to disqualification if they have made misleading or false representations in the forms, statements and attachments submitted in proof of the qualification requirements and incomplete filling of details in the prequalification document.
- 11. The evaluation of pre-qualification will be done based on the information provided by the contractor as per the documents uploaded through e-procurement. The correctness of the uploaded documents will be verified if necessary.
- 12. Conditional tenders will be rejected. The officer competent to accept the tender shall have the right to reject any or all the tender without assigning any reason whatsoever.
- 13. Taxes will be deducted at the prevailing rates.
- 14. The intending bidders are advised to visit the site of work before attending and also submitting their tenders.
- 15. Karnataka Neeravari Nigam Ltd., Reserves the right to verify the correctness of the statements and documents furnished and inspect the jobs executed by the agency/firm, if found necessary.
- 16. The Tenders are invited as per Standard tender Bid Document of KW-4

- 17. All relevant documents as per the KNNL need to be uploaded while submitting bid in general documents provision in e-procurement portal.
